### **Expression of Interest**

Expression of Interest is your opportunity to tell us about yourself and help us understand how you would like us to communicate with you and any issues of interest to you.

We aim to have a broad representation of the people we care for and a balance of experience, opinions and diverse backgrounds. Knowing a little about you helps us with this, however, you are not obliged to provide personal information if you would prefer not to.

Participation in the Caring Hands Advisory Group is an important task and gives you the opportunity to provide feedback on aged care services, network with others, and contribute to improving aged care services.

### **Privacy**

Southcare's privacy policy documents how we manage information. This complies with the Privacy Act 1988 and the Australian Privacy Principles. Any information you provide in the Expression of Interest will only be used for the purpose of the Caring Hands Advisory Group.

### **Eligibility**

All customers, family members, carers and representatives who want to use their voice to represent the views of our Southcare Stars who receive our services can submit an Expression of Interest to join our Caring Hands Advisory Group.

A selection process will be applied, if a higher volume of expression of interests are received than Caring Hands Advisory Group meeting positions are available.

### If you are unhappy about your care

Participation in our Caring Hands Advisory Group does not impact the care and support you receive from us. If you have a concern or issue related to your care this can be raised using our usual feedback process. The advisory group is not designed to deal with individual issues and will not be discussed; its focus is on the overall quality of our service.

### Raising an issue

The Caring Hands Advisory Group represents all customers, and it may not be possible to cover every issue.
